- SBIC was well attended.
- SCA AGM we continue to be in a strong position.
- Attended meetings with SARM and SSGA on coordinating our lobby efforts to both the federal and provincial governments, and aligning on issues of mutual interest, particularly about disaster relief programs and irrigation expansion. Future meetings are planned to continue the communications.
- Meeting held with Carla Beck & Trent Wotherspoon to discuss priorities of the livestock community were discussed. Issues were pointed out where the NDP could support the

government, particularly around rural crime and the newly announced Saskatchewan Marshalls program. Discussed major concerns with Bill C-21 and welcomed to keep the dialogue on going.

- Attended NCBA with Past-Chair Arnold Balicki.
- Many conversations with out American counterparts regarding the future of the beef industry.
- Similar challenges are around competition in the packing sectors, facing headwinds with increased environmental regulations, increased costs related to inputs, etc.
- Eye opening they are much further behind in terms of traceability, which is a serious concern to producers when the topic of diseases and pathogens such as FMD comes up.
- Attended a trilateral meeting with US/Canada/Mexico, and disease was a top priority in that discussion.
- An interesting point made by the deputy agriculture secretary for the Biden administration was that agriculture and cattle producers, in particular, were good for the environment and were some of the lowest carbon intensity protein producers in the world.
- Attended many sessions with a priority placed on sustainability, profitability and communications and marketing.
- Met with a number of State organizations as well as the Canadian consulate offices, and commitment to continue conversations as well as potentially attending or hosting joint meetings or sending producers to events where we can continue to build these relationships.
- Had a meeting with GAARS regarding cost of production insurance for the livestock sector, and they have committed to coming back to us in April with more information.
- Final consultations with the province regarding SCAP programs.
- We continue to move towards a stronger partnership with AITC to assist with the dome, which is important with the recent retirement of Sherri Grant and the conclusion of the AgriEd program.
