Drought Conversation

- Do we cull our way out? The expense to keep and retain can become overwhelming- is this good BRM?
- Tax deferral breeding age tax exempt to cull then buy back. Now paying tax on a smaller herd as one has to cull, with no money to rebuild.
- A) Cull now B) tax deferral C) rebuild in the next years sell low, buy high need a ¾ year span to buy back due to spike in buy back prices, pastures are beaten down and need moisture, can take years to retain enough surface moisture to become viable.
- Word exemption vs deferral
- What happens if your pastures are in the drought, but the government has not declared our area as a drought relief area? You have culled but are not eligible for the tax deferral?
- Satellite imagery available at the fed level but needs provincial buy in. is this something SCA could investigate get crop insurance on board?

• Land conversions happening as grains have a leg up in in insurance. There are gaps between grains vs forage insurance, therefore people moving to cultivated lands

OutReach Meeting Update

- Went through the different meetings
- Rainfall insurance / grasshoppers
- Vet lack of vets/ concerned about the condition of calves in the following year/ poor water quality/ nutrient deficient copper.
- Access to labour and its shortfalls
- Cost of Production insurance is this an area for SCA to investigate. Risk vs margin of production. Can we build an insurance for us? Unforeseen incidents – weather / drought
- Build a program or advance programs already there. Need a stability, instead of always running to the table when a disaster happens.
- Put together a working group to see if this a viable ask. Need ideas/ suggestions in hand before we move to the government conversations.
- Does Quebec/ Ontario have Cost of Production Insurance? Can this be mirrored in Sask?
- Packers Influences on pricing- unfair practices. Market manipulations.
- Packers just paid out a settlement for Pork? What was this about?
- Programs have penalties for the smaller operations, not accessible.
